Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ■ Social security numbers, dates of birth and other numerical identifiers ■ Names and addresses ■ Drivers licenses, passports and other identification documents ■ Usernames and passwords ■ Internet protocol address and other network activity information ■ Employment and income and other financial related information ■ Account balance and wire information <p>When you are <i>no longer</i> our customer, we continue to retain and share your information as described in this notice in accordance with applicable laws, rules and regulations. We do not sell your personal information.</p>
How?	All financial companies need to share your personal information to run their everyday business. In the section below, we list the reasons financial companies can share your personal information; the reasons we choose to share; and whether you can limit this sharing.

We restrict access to nonpublic personal information about our customers to those employees and agents who need to know that information in order to provide products and services to you. We maintain physical, electronic and procedural safeguards to protect your nonpublic personal information.

Why can't I limit all sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> ■ Sharing for affiliates' everyday business purposes—information about your creditworthiness ■ Affiliates from using your information to market to you ■ Sharing for non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p> <p>You may access and correct your personal information that we process, except where the burden of providing you such access would be disproportionate to the risks to your privacy, or where the rights of other persons would be violated. You may also request erasure of your personal information in certain circumstances. To request access to, correction or, or erasure of your personal data, please contact us as set forth in this privacy notice.</p>
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. New Republic Partners, Inc. and its affiliates include a bank (New Republic Bank), a securities broker-dealer (New Republic Securities) and a registered Investment Advisor (New Republic Capital).
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.
Joint marketing	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> ■ New Republic Partners and its affiliates don't jointly market.
